The present work is thus, an effort to document the activities done in last eleven months of the year since the initiation of the project. Parallelly, this has been also intended to bring out true scope for critical examination by the readers of the report about the grass root situation with a comparative onset of on- going activities and to rationalize the same with the project objective and purpose.

### FROM DIRECTOR'S DESK

Rajasthan is the Second largest atrocity prone State in India. According to the Census 2001, the population of Rajasthan State is 5, 65,07,188 and Dalit constitute 17.16% (709776) in the total population. Rajasthan



retains much of its feudal ans caste ridden nature of society, characterized by social exclusion, every day humiliation, discrimination, untouchability and other human rights violations against Dalit people. Dalit posse very marginal and small piece of agricultural land, The feudal mindset prohibits Dalit access to public services and place and limits their participation in democratic institutions. Dalit live a life of extreme dependency on dominant caste communities for their livelihood, maintain a cultutre of silence against untouchability and discrimination, have a very little space in democratically build institution and are caught up in the unequal and inhuman system, They live a life of extreme poverty and lacks basic amenities like food, water etc. Although laws exist for securing their rights but unawareness, lack of resources and courage to fight for the rights make them silent and even more vulnerable. The administration, police and politician, most of time subscribing to the caste values and biases do not uphold Constitutional provision and legislation in ensuring fairness. equality or prescribed protection of Dalit communities.

Under the EIDHR project we are looking five atrocity prone districts. Present report is focusing eleven month activites from February 2007 to January 2008. CDR, a leading civil society organization in the state has taken up monitoring and advocacy on all Dalit Rights issues. We are also trying to provide our utmost effort towards sensitization and developing realization among civil society towards the issue of dalit Human Rights and present situation of Dalit in Rajasthan, thus apart from the project activites as indicated in the report, we are also conducting and organizing various such activites which are essential for promoting and defending the Dalit Rights in Rajasthan.

Hope this report will focus all project activites. I would like to express my thanks and support to State Coordinator, Mr. Soukat Bhattacherjee and his other colleagues who has done hard work in this project and for presenting the spectacular report.

### INTRODUCTION OF PROJECT

In this context different National and International organization has step up to promote and defend the right of Dalits in India through citizen's approach towards achieving equality and realization of rights of Scheduled Caste and Scheduled Tribes in India. This Project is a Joint venture of 10 State level organizations and three National Level Organizations and is supported by Christian Aid –India and European Commission. The Project has been implemented in 10 States of India including Rajasthan .In Rajasthan Society of Depressed People for Social Justice (SDPSJ) is implementing the Project.

#### INTRODUCTION OF CDR

Centre for Dalit Rights (CDR) is initiative of Society of Depressed People for Social Justice (SDPSJ) seek to defend, protect and promote the rights of poor, particularly the Dalits who are the most vulnerable, underprivileged and exploited sections of the society, through capacity building of Dalits activists, and providing social and legal support as enshrined in the Constitution of India, SC/ST (PoA) Act, 1989 & Rules 1995 and other instruments of social justice.

#### AIMS AND OBJECTIVES OF THE PROJECT

The overall aim of the project is to promote and defend the rights of Scheduled Castes /Dalit communities by using National and International human rights and anti-discriminatory legislations and instruments. However, the specific objective of the Project is as follows:

- ➡ To promote and defend the rights of Scheduled Castes / Dalit communities by using National and International human rights and anti-discriminatory legislation and instruments.
- To capacitate and strengthen the Dalit community in 10 States of India to access the criminal justice administration system in order to reduce the practice of 'untouchability' and to protect themselves from violation of human rights .
- ♣ To evolve a civil society mechanism that sensitizes ,mirrors and inform the implementation, enforcement and monitoring bodies of State, National and UN levels

♣ To engage with the intervention mechanism of the monitoring committees of relevant International Conventions of UN, CEDAW, CRC, ICCPR.

#### PROGRAMME DETAIL

#### 1. Staff Recruitment

The Project initiated from February 1st 2007. The process of Staff recruitment, however, started from January 20, 2007. Application for recruitment of State Coordinator and MIS coordinator were invited through free website for jobs in development sector (www.devnetjobsindia.org) and National News paper (Hindustan Times) from all over the India. 30 applications along with Bio- data were received by the end of January. 7 applications were short listed out of which 4 were for MIS Coordinator and 3 applications for State Coordinator. The interview was held on 6th, February 2007 in CDR office Jaipur by Interview Board comprising of Mr. Paul Divakar, Mr. Anand Bolemira, Mr. R K Akodia and Mr P L Mimroth. Experts from EIDHR, NCDHR and other esteemed organizations. The interview process started at 11:00 am and candidates were assessed on the basis of merit, experience in the field and understanding about the issues, skills of presentation and experiences of management. After the completion of the process two candidates namely Mr. Soukat Bhattacheriee and Mr. Gopal Ram Verma were selected for State Coordinator and MIS coordinator respectively. The result of interview was declared within a week and the selected candidates were intimated through mails. The State coordinator joined from 22nd February 2007 and the MIS coordinator joined on 1st March, 2007.

Similar process was also adopted for selection of District Human Rights Defenders for five Districts of the Project and a formal interview was held on 17th February 2007 and 5 candidates were selected for the same. The names of thus selected candidates are :- Mr Tara Chand Verma (Sawai Madhopur), Mr. Om Prakash Reeyal (Jalore), Ms. Sudha Saxena (Sirohi), Mr. Suresh Chand Barwa (Karouli), Mr. Satish Kumar Lehri (Dholpur)

In the Month of July, CAG State Secretary has also been recruited. Ms. Rekha Verma has been recruited for the performing the Job. But after working till Setember 07, she showed her inability to work as CAG Secretary and thus Ms Mamta Bhendarwal has been recruited as new State CAG Secretary from October 07.

In the month of September 07, the District Human Rights defender of Jalore district was replaced and Mr. Rajesh Parmar was appointed as district human rights defender of Jalore district.

In this context Mrs. Jincy Thomas has been recruited as part time accountant for looking after the accounts of EIDHR project .But after fews months Mrs. Jincy Thomas got better job and left the project. In the month of December, 07 Ms. Meenaxi Sharma has been appointed as State Accountant in the place of Mrs Jincy Thomas. Mr. Gopal Ram Verma has been re- appointed as State MIS Coordinator in the month of November 07. He left the organization in the month of April due to personal reasons. After his departure CDR team was in search of State MIS Coordinator and recruited Mr. Hemant as State MIS Coordinator in the month of September. But he could not turned up Lastly, Gopal Ram Verma showed his interest to join as State MIS Coordinator and he was reappointed.

Tarachand Verma resigned from the post of District human rights defender of Sawai Madhopur and in place of him Mr. Manohar lal Bairwa has been recruited and appointed as District human rights defender of Sawai madhopur.

### 2. First Interaction cum orientation meeting of EIDHR Staff

A preliminary preparatory meeting of State Coordinator, MIS Coordinator and District Human Rights Defenders with CDR officials was held on February 26, 2007 for introduction and initial orientation to the project background an activities. The meeting was facilitated by Mr. P.L. Mimroth Chief Functionary of SDPSJ and Mr. Satish Kumar State Coordinator, CDR. In this meeting, the newly recruited team of EIDHR Project formally introduced and oriented on the project background and need of intervention in the selected districts. Mr. P L Mimroth and Mr. Satish Kumar also focused on the major activities that have been planned for the project period. They also regarded this as a pilot project

which will be carried for promoting and defending the rights of Scheduled Caste and Dalit communities by using National and International human rights and anti discriminatory legislations and instruments.

Along with it a copy of two year proposed project activities has also been given to all district human rights defender for deepening their understanding on the programs. The same has been translated to Hindi for avoiding language problem for them.

### Initial preparation for implementation of project and Setting up of State Office

It has been planned to setup the State Office and district offices formally by first week of March 2007. Identification of places for district offices has been started for this task.

The District Human Rights Defenders are also advised to gather or collect relevant information and datas with regard to their Districts for facilitating to start the activities of the Project in their Districts

The State Office has been set up in Jaipur along with the Office of CDR. The Office Address of the State project is as Follows:

### 3. Participation in National Training Programmes

### 3.1 Training of State Coordinator and State MIS Coordinator

A national level training was organized by National Secretariat from 30<sup>th</sup> March 2007 to 4<sup>th</sup> April 2007 at New Delhi. From Rajasthan the State coordinator as well as the State MIS Coordinator participated in the training. From 3<sup>rd</sup> April to 4<sup>th</sup> April it was planned to organize steering group meeting where the Chairperson of the SDPSJ also participated

#### 3.2 TOT of State Coordinators and State MIS Coordinator in Ahmedabad

The next training of trainers was organized by Centre for Social Justice from 17<sup>th</sup> May 2007 to 21<sup>st</sup> May 2007 at Ahmedabad. For this training, the State Coordinator from Centre for Dalit Rights participated in the training.

#### 3.3 Training of State MIS Coordinator at New Delhi

The third major training was organized by National secretariat at Secretariat House, New Delhi from 7/06/07 to 10/06/07 for training to MIS coordinator. From Rajasthan the State Coordinator of Centre for Dalit Rights participated and got the training.

### 3.4 Training of District Human Rights Defenders in Delhi

The fourth National level training was organized by National Secretariat, at Secretariat House, New Delhi for training to District level Human Rights Defenders where the all five District level Human Rights Defenders from Rajasthan Participated. This training was organized from 10/06/07 to 14/06/07. The State Coordinator from Rajasthan also participated in the last day of the training to prepare comparative planning of activities for implementation in Rajasthan

### 4. Identification of District Human Rights Defenders

As mentioned earlier, all the District coordinators were asked to identify District Human Rights Defenders in their respective districts. The Coordinators have submitted a list of Officials as well as provisional list of District Human Rights workers/volunteers defenders so that they could be contacted for promotion of issues. Also the District coordinators have been instructed to identify lawyers in their respective districts for taking up cases.following is the list of District level human rights defenders/volunteers:

### 5.2 District level Capacity building program for Dalit human Rights Defenders/volunteers.

# 8. Engagement with Administration , Judiciary and Law Enforcement Agencies

(Activity code: 3.2)

### 8.1 Police Sensitization Training

With an objective to build up rapport with the police administration and other Law Enforcement Agencies, a two days district police sensitization workshop was organized by Centre for Dalit Rights in collaboration with Dholpur Police Department to sensitize and aware different police personnel ranging from constabulary level to Dy. S P level. In this sensitization program more than 40 police personnel participated. From CDR, P.L. Mimroth, Advocate, R.K. Ankodia, former member State Human Rights Commission and Soukat Bhattacherjee, Participated as resource persons. Detailed report has been attached as **Annexure VI**.

### 9. Monitoring of employment of manual Scavengers.

(Activity code: 3.5)

### 9.1 Survey on manual Scavengers

At Dholpur district, a short survey was done to analyse the situation of manual scavengers. Till July, 2500 dry latrines have been assessed and some photography as been done to determine the status of manual scavengers and dry latrines in this district.

Similar survey was also done in Karouli district where evidence about dry latrines and existence of manual scavenger was found. This survey was done in collaboration with team of SKA, jaipur.

### 9.2 State level workshop on problems and issue of Manual Scavenger

A one day, State level workshop was organized on the problems and issues of Manual Scavengers where different Human rights activist including some activist from manual scavenger community also participated. Different government Stakeholders also participated in this program. Bullu sarin and B. Wilson from National secretariate also participated in this training. Detailed report of this workshop is being attached as **annexure VII.** 

### 10. Monitoring of Dalit Child rights to education

(Activity Code: 3.4)\

### 10.1 Survey on schools of District

Preliminary surveys are going on in the projected districts for getting the status of dalit child rights to education. This preliminary survey was done in Dholpur, Sirohi and Karouli during this period. The preliminary outcome of the survey shows that in most of the private schools Dalit Children are not getting scholarships provided by the government. Nextly, the government schools also are not properly providing scholarships to Dalit Children. Caste Discrimination is prevalent in both government and private schools especially in rural outskirts. In Government hostels, both girls and boys inmate are not getting proper food and nutrition and the hostel atmosphere is also inhyhenic. Datas have been collected from all the districts .The tabulation of Data is in process.

# 11. Training of Advocates / Formation of Advocate's Panel (Activity code : 3.6)

With reference to the capacity building workshop of Dalit advocates in different projected districts, a follow up process was initiated in the month of January 2008. The team of EIDHR along with the team of CDR visited all the projected district to organize one day follow up meeting of Dalit advocates in each five districts and from, each district five competent advocates were chosen to take

up the cases of Dalit victims of atrocities for securing justice through legal tool. Detaillist of members of Advocate panel is given in following:

# 13. Advocacy with other forum and State legislative Assembly members (Activity Code: 4.2)

Centre for Dalit Rights, under the activities of Advocacy met with different stakeholders of State Human Rights commission to discuss in plight of Dalit issue. A prolong discussion took place between the chairperson of CDR and the Chairperson of State Human Rights commission. Detailed report of the meeting is attached herewith as an **annexure IX**.

Similar interaction was also done with DG police and Principal home secretary of Rajasthan for ventilating the voice of Dalit and promoting their rights. Along with this discussion on the major cases of atrocities for providing relief to the victim was also done.

### 14. Intervention to State and National Statutory Bodies (Activity code: 4.3)

The team of CDR continuously intervening in the process of State and National Statutory bodies. CDR has forwarded many letters to the bodies on different fact finding cases as a follow up action and also received response on such cases from National Human Rights Commission and State Human Rights Commission With, CDR team raise advocacy for land and economic rights of Scheduled Caste and protested against State Government's conspiracy to amend the Clause of Section 42(B) of Rajasthan Tenancy Act 1955 where there is a prohibitory provision of selling and purchasing, mortgaging and transferring of land of Scheduled caste to Scheduled caste person only.

# 15: Orientation of District vigilance and monitoring committees (Activity Code: 5.2)

Orientation of members of District vigilance and monitoring committee was done by CDR team in five different project district with a meeting with the members and discussion about the status of Dalit in Rajasthan. Also they have been provided different Status report. Detailed report has been attached as an **Annexure XI**.

#### 17. Administration and Accounts

For Better performance and smoothening the administration work, initiatives have been taken in this regards .All the staff have been advised in this regard to pay

attention to project rules and regulations. Especially in the matters of accountancy, staffs has been advised to prepare proper bills according to the instruction. An orientation has also been given towards proper documentation and proceed billing. Monthly Financial report and Quarterly financial report has been prepared in this respect.

#### **18 INVOLEMENT IN ORGANISATIONAL ACTIVITIES**

### 18.1 Staff capacity building program

An exposure visit was conducted to Mount Abu for the purpose to organize annual meeting of Staff of the Partner organization. The EDHR team also visited Mount Abu and participated in the training process .Issues like Fact Finding Strategies, Major policies and Act for promoting Dalit Human Rights, Building up good Network Strategies, Monitoring, Evaluation and Documentation techniques were also discussed in the training.

### 18.2 Participation in Rally to protest against attack on Christian Priest

The State Coordinator of EDHR team also participated in Rally to protest against sudden attack of some anti social element from a political party on Walter Pastor Masin, a Christian priest at Jaipur

### 18.3 Participation in One Day Seminar Organized by IDS on Agriculture

The state Coordinator participated in one day seminar organized by IDS on Agriculture in Hotel Jaipur Palace for promotion of Agriculture in Rajasthan and also promotion of Land development and reformation in Rajasthan.

### 18.4 Participation on one Day meeting on Rally and agitation on various Social Issues organized by Mazdoor Kisan Sangarsh Samiti

A meeting was called by Mazdoor Kisaan Sangarsh Samiti (MKSS) at Samagra Sewa Sangh Jaipur for Conducting a Rally and Agitation for various social issues including Dalit Atrocities and welfare issues in the month of June where the State Coordinator participated.

### 18.5 Participation in two days Conference on Food Security –challenges with Society organized by Indian Social Institute, New Delhi

A workshop was organized by Indian Social Institute, New Delhi at ISI house, New Delhi, on food security –challenges with society in the month of June where the State Coordinator participated. The main objective of the training is to impart knowledge about food security in various parts of India along with gender discrimination and other related Social Issues.

# 18.6 Participation of District Coordinators in external organization programs

The District coordinators at their respective districts have attended different training and capacitation programs and consultation meeting from time to time. Most of these trainings are organized by other nongovernmental organizations, women groups at block and district level.

### 18.7 Participation in State level Staff Capacity Building program at Jaipur

The EIDHR team also participated in Staff capacity building program organized by CDR at Samagra Seva Sangh, Durgapura Jaipur on 3<sup>rd</sup> and 4<sup>th</sup> November 2007. Here all the EIDHR team under the able guidance of the Chairperson of CDR and other resource person learned and gathered knowledge on different aspects of working which included field level working and desk jobs. This team was also being capacitated through detailed discussion and practice on complaint letter writing and fact finding etc.

# 18.8 Participation in State level Mass Raily on Dalit Land Rights organized by CDR

The team of EIDHR project of all projected district participated in State level rally conducted from 4<sup>th</sup> December 2007 to 10<sup>th</sup> December 2007 to support and cooperate the CDR team and also to promote and ensure the protecting lands rights of Dalit in Rajasthan . In this period different activities were organized in different district including meeting with the District level Stakeholder and organizing mass meeting followed by signature campaign for registering protest against Government's conspiracy to amend Section 42(B) of Rajasthan Tenancy Act 1955.

### 18.9 Zender Training Program

Centre for Dalits Conducted one day workshop on Zender sensitization at Samagra Seva Sangh , Durgapura , Jaipur on  $4^{th}$  November 2007 where the EIDHR team participated. In this training Ms. Mamta Jeitly , specialist in zender training and women activist facilitated the team . She also provided different material to the team memberon Zender issue.

### 18.10 Workshop on Dalit women in Rajasthan

Centre for Dalit rights conducted two days State level workshop on State of Dalit women in Rajasthan, where the EIDHR team participated. This workshop was conducted at State Institute of Health and Family Welfare, Jhalana Institutional Area, Jaipur where different resource person including Pual Divakar from NCHDR, New Delhi participated and facilitated the session. This workshop was conducted in collaboration with All India Dalit mahila Manch.

### 19. FEW AREAS OF ACHIEVEMENTS

- Level of awareness and contacts / liaison through net work and activities
  of Dalit groups across the state considerable increased, over 1000 Dailt
  activists and associates all over the state and they are now on the roll of
  volunteers of Centre for Dalit Rights.
- 2. Number of F.I.R's and Conviction rate in SC/ST Act and statutory relief to the victims increased around 30%. It was also observed that majority of F.I.R'S were got registered at the instance of Court intervention under Section 156(3) of Criminal Procedure Code.
- 3. Administration and law enforcing agencies also sensitised towards SC & ST problems.
  - I. Issuance of Special directions to all SP'S for proper and prompt investigation of SC/ST cases.
  - II. Instructing all SP'S of the state to entertain the CDR Representatives and redress their problems/ grievances.
  - III. Police started organizing orientation programmes on PCR Act and SC & ST Act for police personals in many Districts by inviting CDR as resource person.
  - IV. The State Govt. for the first time since 1995from the enactment of Rules of SC & St Act constituted the State Level Monitoring & Vigilance Committee under the Rule 16 of the SC/ST Act 1989.
  - V. District Level Monitoring & Vigilance Committees formed and activated in all 32 Districts at the instance of CDR.
  - VI. Substantial increase in the granting of interim relief and monetary assistance provided to the victims under the SC/ST Rules.
  - VII. Govt. banned using the *Harijan* word in the official correspondence and record and public functions at the behest of CDR.
  - VIII. Department of Social Justice & Empowerment of the State Government for the first time published big posters containing important provisions of SC & ST Act & Rules and displayed in local police stations besides publications of the same in one full page advertisement in all the daily newspapers of the stat.

Department of Social Justice & Empowerment also released a sum of one lac rupees to each District administration for launching campaign against *untouchability* and *atrocity* free year after repeated pursuance of CDR.

- IX. State Govt. set up recently the State Level Commission for SC & ST.
- X. CDR organized a State Level seminar on "Dalit Budget and Special Component Plan" in jaipur on 21<sup>st</sup> April 07 highlighting the diversion and lapses of allocated fund in the Budget and non- implementation of Special Component Plan in the State and thereafter as a follow up action, Mr. Madan Dilawar Hon'ble Minister for Social Justice & Empowerment convinced Special meeting of concerned officials and pulled them up directing to implement the provisions of Special Component Plan and other budgeting guidelines in all Departments.
- XI. The CDR launched a Campaign for police reform with special reference to Dalit problems and succeeded in incorporating a special provision in the Act providing representation to weaker section and women in the State Level and District Level Committees to act as "watch- dog" outfit against police excesses.
- XII. The National Human Rights Commission invited CDR to assists to organize Training on Human Rights in Rajasthan.
- XIII. The CDR first ever orgainsed a dialogue with MLAs in Assembly on various Dalit Issues.

#### 20. ORGANISATIONAL MATTERS

CDR currently has a team of twenty five people including the programmes of EIDHR and DWAJ. Ten members are placed in the ten districts to coordinate the various interventions. The state level team consists of the Director, Programme Coordinators (Core programme, DWAJ, EIDHR), Media secretary, administrative, finance and MIS staff. The chairperson, Adv. P.L. Mimroth gives considerable time to the organization and its interventions. In addition CDR has been able to recruit a number of volunteers and human rights defenders, both women and men at the district and state level.

In keeping with the growth and needs of the organization, various capacity building programmes were undertaken during 2007. These included training in legal monitoring and fact finding, laws related to land, advocacy and campaign strategies, gender sensitization and finance and accounting. FMS organized a training in financial matters. A number of members of the core programme staff have been with the organization since the beginning of the programme and have picked up skills through work experience and organizing programmes on their

own and in collaboration with other organizations and networks. DWAJ and EIDHR have provided capacity building opportunities with different partner organizations and at the natonal level. In addition, the organization has also facilitated team members to participate in various trainings organized by the state and other NGOs.

The Board Members have met three times during the year to review and guide the organization and interventions. The involvement of the chairperson and other eminent members of the board and civil society have further helped inspire and mentor the team in their tasks.

Currently CDR has a fairly equipped team to carry out the core programmes as per plan. However the organizational capacity in administration, documentation, articulation of issues and transforming itself into a resource and networking oranisation needs further strengthening.

#### 21 . LIMITATION

- 1. In this year a short constraints have been experienced about disbursement of budget from National level at initial stage for starting project activites. However by the end of April .Problem has been sorted out.
- 2. It was expected to set up district office within this interval of time but due to adverse political and social situation it could not be done. However; this has been decided to mobilize local support for sorting out the problem. It is to be noted that there is no budget allocation for this purpose. However the district offices has been set up in the end of month of September.
- **3.** This year due to excessive work load of the PIA member's limited progress was made towards formation of Citizens Audit Group. Moreover most of the proposed members were not available during this time.
- **4.** Due to Gurjar Movement in Rajasthan the work speed has been slowed down for more than one month during the month of May and December 07
- **5.** There is a problem faced by the organization in consistency of the EIDHR personnel as some new Staff joined and left the organization for their personal reasons due to which work of the project suffers suffered in this interval.

#### **DEVIATION OF PLAN**

There were many deviation from plans has been noticed as the adverse sociopolitical condition of Rajasthan. Many activities have been shifted from its proposed month to other times and many of them have been suspended due to similar reasons. However the PIA and the EIDHR team have been trying to cope up with the situation.

### **HARDSHIPS**

- 1. Dispartity in the perls of District Human Rights defenders
- 2. Non provision of funds for District level office and very smerge provided under the head. Other activities like Fact finding mission are less funds to be operated properly.
- 3. Non provision of staff welfare and social security measures.
